#### FACILITIES, OUTDOOR.

(d) Perimeter fence. On or after May 17, 2000, all outdoor housing facilities (i.e., facilities not entirely indoors) must be enclosed by a perimeter fence that is of sufficient height to keep animals and unauthorized persons out. Fences less than 8 feet high for potentially dangerous animals, such as, but not limited to, large felines (e.g., lions, tigers, leopards, cougars, etc.), bears, wolves, rhinoceros, and elephants, or less than 6 feet high for other animals must be approved in writing by the Administrator. The fence must be constructed so that it protects the animals in the facility by restricting animals and unauthorized persons from going through it or over it and having contact with the animals in the facility, and so that it can function as a secondary containment system for the animals in the facility. It must be of sufficient distance from the outside of the primary enclosure to prevent physical contact between animals inside the enclosure and animals or persons outside the perimeter fence. Such fences less than 3 feet in distance from the primary enclosure must be approved in writing by the Administrator.z

There are areas of the wood perimeter fence that have broken panels and leaning outward. There are areas of the wire perimeter fencing that is too flimsy not supported by posts. These areas of the perimeter fence do not protect the animals in the facility by restricting animals and unauthorized persons from going through it or over it and having contact with the animals in the facility, and so that it can function as a secondary containment system for the animals in the facility.
