 - (i) Have no sharp points or edges that could injure the nonhuman primates;
 - (ii) Protect the nonhuman primates from injury;
- (iii) Contain the nonhuman primates securely and prevent accidental opening of the enclosure, including opening by the animal;
- (iv) Keep other unwanted animals from entering the enclosure or having physical contact with the nonhuman primates.

The red ruffed lemurs are able to stick their entire heads through the chain mesh of their enclosure. This was witnessed during the inspection. This must be addressed to protect the animals from injury and to prevent other animals from having physical contact with the nonhuman primates.
