 Fines and Cost will be automatically taken from the cash bond.  
 The Court having determined that all costs, assessments, surcharges, and fines imposed in this Judgment are in accordance with Florida law,  
 The Clerk of the Circuit Court is directed to certify this Judgment and record it in the Official Records of Pasco County, Florida. The Clerk may also record this Judgment in each county in which the defendant now owns or later acquires property. A Judgment Lien is created in favor of the Clerk of the Circuit Court on behalf of the State of Florida for all costs, assessments, surcharges, and fines imposed by this order. Interest shall accrue at the statutory rate. The address for the Clerk of Circuit Court is: 38059 Live Oak Avenue, Dade City, FL 33523 or 7530 Little Road, Net Port Richey, FL 34652.  
 If you violate any of the conditions of your probation, you may be arrested and the court may revoke your probation, adjudge you guilty and impose any sentence which it might have imposed before placing you on probation or require you to serve all or part of any suspended sentence.  
 You are advised that you have the right to appeal both the Judgment and Sentence herein imposed within thirty (30) days hereof. Should you fail to appeal within that time, you will lose your right to do so. You are entitled to the assistance of counsel on appeal and if you can not afford an attorney, the Court will provide you with an attorney for that purpose.
