(c) Surfaces--(1) General requirements. The surfaces of housing facilities must be constructed in a manner and made of materials that allow them to be readily cleaned and sanitized, or removed or replaced when worn or soiled. Furniture-type fixtures or objects must be sturdily constructed and must be strong enough to provide for the safe activity and welfare of nonhuman primate.

\*\*\*\*The Spider monkey enclosure had flaky rusted pipes that makes it difficlut to clean and sanitize.

\*\*\*\*The platform inside the spider monkey enclosure was broken and the the swing inside the lemur enclosue had a broken rope.

\*\*\*\*One metal bar inside the macaque enclosure connected to the center pole was detached due to rust and had jagged edges.

\*\*\*\*In order to clean and sanitize the primate enclosure, piped with excessive flaky rust must be replaced.

\*\*\*\*Metal rusted bars. swings, platforms, etc., must be kept in good repair to provide safe enclosure activity and welfare of nonhuman primate.

#### Sec. 3.131 Sanitation.

(a) Cleaning of enclosure Excreta shall be removed from primary enclosures as often as necessary to prevent contamination of the animals contained therein and to minimize disease hazards and to reduce odors.

\*\*\*The bobcat shelter had accumulation of fecal material, leaves and dirt due to deficient drainig through the wire mesh in the back of the shelter.

\*\*\*In order to prevent disease hazards and to reduce odors excreta shall be removed from primary enclosures as often as necessary.
