Sec. 3.125 Facilities, general.

- (a) Structural strength. The facility must be constructed of such material and of such strength as appropriate for the animals involved. The indoor and outdoor housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury and to contain the animals.
- ****Multiple enclosures (Tiger, lion, hyenas, bear, etc.) had exposed underground wire which may be dangerous to the animals if their paws and/or limb get caught and entangle in the exposed wire.

- ****All water receptacles shall be kept clean and sanitary.
- ****Multiple water receptacles were observed with algae growing in them and the water was cloudy in color.
- ****In order to prevent gastrointestinal disease all water receptacles shall be kept clean and sanitary.

SANITATION.

Sec. 3.131 Sanitation.

- (a) Cleaning of enclosures. Excreta shall be removed from primary enclosures as often as necessary to prevent contamination of the animals contained therein and to minimize disease hazards and to reduce odors.
- ****Multiple enclosures(Tiger,lion,bear,etc.) were observed with accumulation of excreta and food debris. The excreta was dry and white in color indicating that it had been in the enclosure for more than a day.
- ****In order to minimize contamination, disease hazards and to reduce odors excreta shall be removed from primary enclosures as often as necessary.
