Be free of excessive rust that prevents the required cleaning and sanitation, or that affects the structural strength of the surface:

\*\*\* Rusted surfaces were observed on the center beam of the macaque enclosure and on the side panel and bottom pipe of the spider monkeys enclosure.

In order to clean and sanitized the enclosures according to 3.84 of this subpart, surfaces must be spot cleaned daily and sanitized which is not possible when rust is present on the surface.

### FACILITIES, GENERAL.

Sec. 3.125 Facilities, general.

- (a) Structural strength. The facility must be constructed of such material and of such strength as appropriate for the animals involved. The indoor and outdoor housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury and to contain the animals.
- \*\*\*Multiple enclosures (Bears, hyenas and tigers) had exposed underground wire which may be dangerous to the animals if their paws and/or limb get caught and entangled in the exposed wire.
- \*\*\*The Tayra enclosure had exposed nails and screws and the wood was rotted around the entrance door.
- \*\*\* The porcupine enclosure had a hole on the floor close to the edge of the side panel that can be a potential escape route for the animal or an entrance for an outside animal to get in.
- \*\*\*Housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury and to contain the animals.

#### WATERING.

Sec. 3.130 Watering.

- \*\*\*All water receptacles shall be kept clean and sanitary.
- \*\*\*Multiple water receptacles were observed with sedimentation accumulation and the water had a reddish discoloration due to the iron content in the water.
- \*\*\*In order to prevent gastrointestinal disease all water receptacles shall be kept clean and sanitary as often as necessary. A filtration system is in the process of installation but is still not working.

#### SANITATION.

Sec. 3.131 Sanitation.

- (a) Cleaning of enclosure Excreta shall be removed from primary enclosures as often as necessary to prevent contamination of the animals contained therein and to minimize disease hazards and to reduce odors.
- \*\*\*Multiple enclosures (Hyenas, Bear, Lions and Palm Civet) had accumulation of fecal material.
- \*\*\*In order to prevent disease hazards and to reduce odors excreta shall be removed from primary enclosures as often as necessary.

Sec. 3.131 Sanitation.

- (c) Housekeeping Premises shall be kept clean and in good repairs in order to protect the animals from injury and to facilitate the prescribed husbandry practices set forth in this subpart.
- \*\*\*Accumulation of trash and discarded material was observed on the facilities premises.
- \*\*\*Accumulation of trash and discarded material shall be placed in designated areas and cleared as necessary to protect the health of the animals.
