#### FACILITIES, GENERAL.

The ring enclosure for the tigers and lions is used for training and exercise. During the inspection Mo, the lion was laying in the enclosure. The bottom perimeter of the enclosure is not secured to the ground. Inside the enclosure is a grass / dirt surface with no protection around the perimeter in case these animals attempted to dig out. The facility must be constructed of such material and of such strength as appropriate for the animals involved. Outdoor housing facilities shall be structurally sound and shall contain the animals.

#### SPACE REQUIREMENTS.

The tigers and lions at this facilities winter quarters are currently housed similar to traveling status. All the enclosures on the trailer that measure 6' L x 4' W x 4' H, are back to back divided by a row of wood

panels and placed side by side. Each enclosure has a vertical sliding door that can open and close as needed. This provides containment for one or more tigers or lions and movement to and from the exercise / training ring enclosure as needed. During this inspection I observed two lions Bruiser and Roxie in four enclosures with all doors open measuring, 24' L x 4' W x 4' H. Kaya the white tiger and Chi Chi the lion was in a separate enclosure at the rear of the trailer on the ground near the ring measuring, 10' L x 12' W x 4' H. The tigers Sheik and Nippe was in one enclosure that measured, 18' L x 4' W x 4' H. Zules the white tiger was in an enclosure on the ground on the side of the trailer opposite Kaya and Chi Chi that measured 10' L x 12' W x 4' H, not sufficient in height.

Enclosures that are 4' wide do not allow sufficient space to allow each tiger and lion to turn around without bending and rubbing against the wood and wire enclosures. Enclosures that are only 4' high does not allow each tiger and lion to stand on two feet without having contact with the top of the enclosure. The enclosure housing Kaya and Chi Chi measures 12' L x 10' W x 4' H, does not provide enough space for both tigers to allow normal postural movements, social adjustments with adequate freedom of movement. The tigers and lions are rubbing their enclosures due to insufficient space could cause skin irritations and or unnecessary discomfort. The tigers and lions shall be able to stand for stretching, playing, or any reason at all times. Although the tigers and lions do appear to be healthy, they need additional space to allow normal postural movements, social adjustments with adequate freedom of movement.
