- << (c) A class "C" exhibitor shall identify all live dogs and cats under his or her control or on his or her premises, whether held, purchased, or otherwise acquired: (2) By identifying each dog or cat with:
  - (i) An official USDA sequentially numbered tag that is kept on the door of the animal's cage or run;>>

No official USDA sequentially numbered tag was on the door of the cages for 2 of the 8 dogs traveling with the licensee. A maltese/terrier mix dog named Rosie (aka Toto on acquisition paperwork) and a Chihuahua named Fester had no official identification tags attached to their enclosures during this inspection.

Identification of dogs and cats is necessary so that animals can be tracked to ensure their humane care and use in regulated activities.

The licensee shall identify all dogs and cats under his/her control with an official USDA sequentially numbered tag that is kept on the door of the animal's cage or run.

The license did not have complete information for 2 of 8 dogs identified in the record book which contains each dog and cat's official tag number, a written description of each animal, and a clear photograph of the animals. Acquisition records with a description of the 2 dogs, a Maltese/terrier mix named Rosie (aka Toto) and a Chihuahua named Fester, were in the record book but no tag number or photograph were present.
