#### ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

- The last recorded site visit by the attending veterinarian was on 5/10/11. Good communication and consultation between the licensee and the attending veterinarian in the form of a written program of veterinary care and regularly scheduled visits to the premise are necessary for the health of the animals. #### ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

- In the walk-through portion of the park there was a Jacob sheep in thin body condition, with rough hair coat, and excessively long horns. The upper right horn had grown to a length that it was in the sheep's mouth. There were chew marks on this horn. The horn on the upper left had grown to a length that prevented the sheep from grazing unless the grass was approximately 3 inches tall. The excess length of the horns impact the ability of the sheep to eat normally, and harm the health of the animal. The applicant must have this animal examined by a veterinarian to obtain an accurate diagnosis and appropriate treatment plan. The outcome of this consultation must be documented and provided to the inspector upon request. The applicant must ensure that all animals receive adequate veterinary care at all times.

#### HANDLING OF ANIMALS.

- The lemurs public barrier gate was unlocked and allowed the public access beyong the gate and into the primate area. The facility representative stated that the public had access to the area without constant park employee supervision. He stated that empolyees came and went from the area during the day as they preformed their duties.
- The Jacob sheep in the walk-through portion of the park had no public barrier and no park employees were present. The gate to their enclosure did not have a lock and could have been easily opened by the public. The facility representative stated that the public had access to the area without constant park employee supervision. He stated that empolyees came and went from the area during the day as they preformed their duties.
- A camel being kept in an outdoor enclosure in the walk-through zoo had a public barrier less than three feet and could access the public. The facility representative stated that the public had access to the area without constant park employee supervision. He stated that empolyees came and went from the area during the day as they preformed their duties. This animal is in a location which would allow it to easily have contact with members of the public.
- Numerous open and unlocked gates were noted in the walk through facility at the time of the inspection. The facility
  representative stated that the two public schools that had been there that day had left. Asked if public could still enter
  the park and he responded yes. Animals on exhibit must either have public barriers, and/or clearly identified park
  personnel in the vicinity to ensure safety of visitors and exhibit animals.

# 3.81 REPEAT DIRECT NCI ENVIRONMENT ENHANCEMENT TO PROMOTE PSYCHOLOGICAL WELL-BEING.

- The facility is exhibiting three lemurs. The licensee was unable to provide inspectors with a documented plan for environmental enhancement. All facilities with primates are required to have a documented and appropriate plan to ensure adequate environmental enhancement for the animals, and to ensure that specific psychological needs of the primates are being identified and addressed.

## FACILITIES, GENERAL.

- The food storage shed for the walk through park contained torn bags of food, with a portion of the contents spilled onto the floor. The shed also had a considerable amount of spilled feed beneath the pallets and along the walls. Spilled feed is an attractant for rodents and pests, which could potentially lead to contamination of stored feed and bedding in the area. The area immediately around the food storage

shed was also overgrown with weeds, and contained several items of unused material. This is potential harborage for pests and rodents. The area around the storage shed should be cleared to help prevent rodent/pest infestation.

## FACILITIES, OUTDOOR.

- Two cavvys being kept in an outdoor enclosure in the walk-through area of the park did not have adequate shelter. The existing shelter is an igloo style dog house in the enclosure. This igloo dog house does not allow sufficient room for both animals to provide adequate protection from wind, rain, and any other environmental effects. This is a potential impact to the health and welfare of the enclosed animals. All animals in outdoor enclosures must have adequate natural or artificial shelter to provide protection from the weather.
