2.40 (b)(2) REPEAT

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Section 2.40(b)(2) states "Each exhibitor shall establish and maintain programs of adequate veterinary care that include the use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries, and the availability of emergency, weekend, and holiday care."

Several animals need their hooves trimmed due to overgrowth and curling to the side of the claws. These animals include a black goat with 3 overgrown hooves in the middle pen near the bus loading area; the white alpaca in the same area with an overgrown right rear claw; a young yak with overgrown rear claws housed with two goats; a white alpaca and one of the black alpacas in the group next to the yaks have overgrown claws. All of these animals need their feet trimmed to prevent deformities, and all animals need to be observed more carefully to provide trimming when necessary.

3.125 (a)

FACILITIES, GENERAL.

Section 3.125(a) states "Structural strength. The facility must be constructed of such material and of such strength as appropriate for the animals involved. The indoor and outdoor housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury and to contain the animals."

In the safari outback area many of the trees in the camel and sika deer pastures have Christmas tree lights hanging down to where the animals can access them. Because some of the deer have antlers which could become tangled in the lights, the lights need to be kept removed to prevent potential injury. All structures need to be maintained to prevent potential injury to the animals. To be corrected by 5-31-13.

SANITATION.

Section 3.131(a) states "Cleaning of enclosures. Excreta shall be removed from primary enclosures as often as necessary to prevent contamination of the animals contained therein and to minimize disease hazards and to reduce odors."

Inspection Report

There is an excess accumulation of old and new feces in the gravel floored concrete enclosed shelter for the two wildebeast. The caretakers were trying to create a "pack" of old feces and hay to build up and hold in heat to provide a warmer environment for the wildebeast. Instead of a hard packed pack, there appears to mostly be a layer of feces in the bedding and feces in the large gravel where there is no bedding. Feces needs to be picked up on a regular basis to prevent excess accumulations, in order to reduce disease hazards, pests, and odors. To be corrected by 5-17-13.
