This inspection did not address all of the animals or animal areas at the facility. It was a follow-up on the inspection of 4-2-99 to observe veterinary care for a tiger. The trace mineral block located on the ground in the Fallow deer enclosure during the inspection of 4-2-99 was not reinspected, so this Category IV repeat non-compliant item was not re-evaluated on this inspection.

Accompanied on inspection by the attending veterinarian that provides care for the felids, and by David Silvester and Martin Aaron who are the Curators for Lagoon Corporation.

--The male lion named "Rhondo" has received a veterinary evaluation and medical treatment involving supplements for anemia and medicine for arthritis has been instituted. Abnormal kidney function was confirmed. Not enough time has elapsed since the 4-2-99 inspection to determine whether a program of adequate daily observation to assess health and well-being with an adequate mechanism of direct and frequent communication with the attending veterinarian has been successfully developed. Some records are being kept. The person(s) doing the daily assessment of health and well-being must be adequately trained to make an accurate assessment. This will receive further evaluation in subsequent
