CATEGORY IV: Non-compliant item(s) previously identified that have not been corrected. Veterinary Care, section 2.40

-- During the inspection, the written program of veterinary care was reviewed to determine facility compliance with the established program. The current written program of veterinary care dated 4-15-99 calls for "Bi-annual (spring and fall)" under the heading of "Parasite frequency of sampling/treatment". The peccary evidently did not receive either sampling or treatment for parasites in the almost one year since the written program of veterinary care went into effect. Both the facility records and the attending veterinarian's clinic information were consulted to determine that the peccary had not received any treatment or sampling. The facility shall establish and maintain programs of adequate veterinary care that includes the use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries. Lack of compliance with the written program of veterinary care was previously cited on the 6/29-30/99 inspection report.

This is a notice that you have had the same violation(s) documented on the last two inspections. You are being given the opportunity to correct these violations. If similar violations are documented on subsequent inspections, all past and future violations may be used as evidence for formal legal action against you.

CATEGORY III: Non-compliant item(s) identified this inspection Records, section 2.75 (b)

--The acquisition records for each of the two camels (Kersey and Lugar) do not have all of the required information. They both lack the USDA number for Al Deutsch from whom Lagoon purchased the camels. Provide the information required in section 2.75 (b) on all acquisition and disposition records.

To be corrected by: 4-15-00 on Kersey and Lugar's records and immediately on all future records.

CATEGORY II: Non-compliant item(s) previously identified for which time remains for correction.

"D" Veterinary Care, section 2.40 (b)

--The inspector was not able to determine whether the problems have been resolved regarding providing adequate assessment of health and well-being so that timely and accurate information on problems of animal health, behavior, and well-being is conveyed to the veterinarian and that appropriate veterinary care is obtained. This will be evaluated further in future inspections. Previous correction date was 3-1-99.

"D" Employees, section 3.132

--The inspector was not able to determine whether the problems with inadequately trained employees and supervisors has been corrected to the extent that the animal care staff can maintain the professionally acceptable level of husbandry practices as set forth in Subchapter A--Animal Welfare. This will be evaluated further in future inspections. Previous correction date was 6-15-99.

NOTES:

- 1. A copy of the Perimeter Fence Reguirements which was published in the Federal Register on 10-18-99 was discussed and left on site along with a letter detailing the process to use in requesting a variance.
- 2. The facility was not able to furnish a necropsy report for the camel (Kersey) which died on 3-5-2000. However, the attending veterinarian stated that a necropsy was performed and that it revealed the animal died from peritonitis associated with a perforated ulcer.

- 3. The facility has not signed the written program of veterinary care dated 4/99. This lack of signature was previously discussed with the facility representative on a previous written program of veterinary care on 2-10-99. Please sign the current written program of veterinary care by 4-15-00. It will need to be on site and available for the inspector's review during the next inspection.
- 4. The facility has not yet proceeded with the external training proposed in documents last fall. The external training was proposed for Spring, 2000. Jody Christiansen reported that there had been an approximately 1 hour training session by Dr. Clayne White on 11-5-99 and an approximately 2 hour training session by Dr. David Hill on 10-28-99. In a telephone conversation with Ms. Christiansen on 3-31-00, she reported that the external training will probably occur in late April or in May, 2000.
