(b)(1) Every exhibitor shall make, keep, and maintain records or forms which fully and correctly disclose the following information concerning animals purchased or otherwise acquired, owned, held, leased, or otherwise in his or her possession or under his or her control, or which is transported, sold, euthanized, or otherwise disposed of by the exhibitor. T (i) The name and address of the person from whom the animals were purchased or otherwise acquired; (ii) The USDA license or registration number of the person if he or she is licensed or registered under the Act; (iii) The vehicle license number and State, and the driver's license number (or photographic identification card for nondrivers issued by a State) and State of the person, if he or she is not licensed or registered under the Act; (iv) The name and address of the person to whom an animal was sold or given; (v) The date of purchase, acquisition, sale, or disposal of the animal(s); (vi) The species of the animal(s); and (vii) The number of animals in the shipment. (2) Record of Animals on Hand (APHIS Form 7019) and Record of Acquisition, Disposition, or Transport of Animals (other than dogs and cats) (APHIS Form 7020) are forms which may be used by exhibitors to keep and maintain the information required by paragraph (b)(1).

In the end of January or early February, this licensee transported tigers to a USDA facility in Missouri, however no records are were available during this inspection. During this inspection I spoke to licensee Alain Zerbini by phone about transporting tigers from a USDA facility in Florida to Missouri. Mr. Zerbini stated he did not transport the tigers under his USDA license, only leased his transport vehicle and the driver. No records were available for this transportation. This licensee used his transport vehicle and employee to transport these tigers therefore shall make, keep, and maintain records or forms which fully and correctly disclose the required information.

**SANITATION.**

(d) Pest control. A safe and effective program for the control of insects, ectoparasites, and avian and mammalian pests shall be established and maintained.

I observed excessive flies on the Camels face area during this inspection. Several times the camels were shaking their heads attempting to remove the flies. For the health and well-being of these camels, there needs to be a safe and effective pest control program.

This non compliance is corrected. During this inspection the facility treated the camels to reduce the flies, however a future inspection will be conducted to ensure this treatment is effective.
