The fence must be constructed so that it protects nonhuman primates by restricting unauthorized humans, and animals the size of dogs, skunks, and raccoons from going through it or under it and having contact with the nonhuman primates. It must be of sufficient distance from the outside wall or fence of the primary enclosure to prevent physical contact between animals inside the enclosure and outside the perimeter fence. Such fences less than 3 feet in distance from the primary enclosure must be approved by the Administrator.

- Insure that a sufficiently high and strong public barrier is in place to protect the viewing public and subsequently the tiger.
- There is no barrier between the person being photographed and the tiger.
- The person being photographed is considered a member of the general viewing public and therefore there must be an additional barrier between that person and the tiger.
  - Insure that there is a sufficiently high and strong barrier between the tiger and the person being photographed.
